Stamp Duty Land Tax may be payable on your property purchase. Please note that there is a premium rate of SDLT payable on second properties or purchases by a company. We will advise you of the amount payable at the outset of the matter once the specifics of your transaction are known. If you are a first time buyer and have never owned before, there is an exemption for purchases up to £300,000 and a reduced rate for purchases between £300,001 and £500,000.

We will act as your "tax agent" for the purposes of SDLT in connection with your purchase. This means that we will complete the Land Tax Return form on your behalf and ask you to sign a draft copy. We will complete the final details for you and will submit the form to HM Revenue and Customs, together with your payment of the tax due (if any), immediately after completion has taken place.
